Treasurer, Bob Reynolds, gave an update on the finances; the return on interest has been very good especially with the change in banks. We are over projected earnings for the year with the closings that occurred in December – current funds \$699, 477.43.

Nays: none Carried Cam Hall, inquired about the possibility of investing the funds in savings due to the amount of cash on hand. Doyle and Strong both stated the limitations state law puts on investment opportunities. Certificates of Deposit are a consideration however they lock up funds – would need to stager into several CDs to align with investment strategy. At the current time the change in banks and increase in interest rate is serving the company well. Bob Reynolds mentioned the recent transfer of funds from checking to savings due to the better interest rate in savings.

Executive Director Update:

- -Annual audit review and preparation are under way. The net financial position of the HIDA is up 32% LDC is up over 12%.
- -The 2020 PILOT Bills have been mailed. This year Eric County taxes have been added to the PILOT bill which makes us consistent with other local IDAs. We were the only IDA who did not include the county tax on their bills.
- -The 2019 Employment surveys have been mailed.
- -The Hamburg Development Corporation Annual meeting was held in January. Invest Buffalo was the guest speaker which worked out well as we are an investor with Invest Buffalo this year.
- -Doyle has been in contract with a potential investor with the intention of turning vacant retail space in Hamburg into apartments. The project is still the talking phase and remains confidential.
- Andy Palmer, gave a shot out to Director Doyle who was recognized along with the HIDA in a feature article in the December 27th Edition of Business First as well as Doyle noted in the January 24th edition as one of the "Builders of the Future".
- -Doyle stated he will be leaving this afternoon for the NYS Economic Development Council Conference in Albany.
- -Doyle stated there has been activity on the Norfolk Southern sight but no other projects to mention.
- -Bob Reynolds, inquired about the activity at Gateway (the old Big Tree Fire Hall). He stated the building is up for lease. Doyle met with the owner last year. Gateway met the job requirements of the PILOT in 2018. Doyle will review his 2019 survey due in February.

ANNUAL MEETING - Committee Assignments

-Doyle stated he received a call from Jeff Brylski yesterday, he will be resigning from the Board and an official letter will be forthcoming. He told director Doyle his current job commitments do not lend the appropriate time to put forth on this Board.

This change in the Board of Directors will leave the Secretary position open. Director Doyle explained the additional commitment of the secretary is to attend the Executive Committee meetings approximately once a month for about an hour which can be done via conference call.

Andy Palmer nominated Cam Hall as secretary of the HIDA Board.

-Director Doyle reiterated the decision at the HIDA offsite planning meeting in November to officially change the agency's mission statement to the following:

Consistent to the authority granted by the State of New York, it is the mission of the town of Hamburg Industrial Development Agency to advance the job opportunities, wellness, general prosperity, and economic welfare of the people of the great Town of Hamburg, New York. This is accomplished by enthusiastically working to promote, attract, encourage, and develop recreation, economically sound commerce, and industry for the purpose of maximizing employment and property value for the Town and its residents.

Guiding Principles

The Town of Hamburg Industrial Development Agency will achieve this mission, utilizing the powers granted by New York State, through providing financial assistance to qualified projects. This assistance shall include conduit bond financing, lease/leasebacks, exemptions from taxation, and support to organizations with similar missions.

The board and staff of the Town of Hamburg Industrial Development Agency are charged to carry out this mission guided by the tenets of Transparency, Integrity, Accountability, and Exemplary Customer Service.

-Director Doyle stated <u>yearly</u> Sexual Harassment Training is requirement by NYS for all Board members and employees of the HIDA. -Director Doyle reviewed the Property Disposal Guidelines. The guidelines follow state law. The board is required to review the policies yearly. Doyle is keeping a list of items he has purchased thru the IDA that do not fall under property of the Town of Hamburg such as; his new laptop, camera and equipment to video record board meetings and two new computer monitors for the office.
