

#### **Executive Director Update:**

- -Crossroads site waiting on submitted grant application.
- -Several inquiries for businesses looking for 2/3 acre parcels the cost to put infrastructure in at the Crossroads site and subdivide as such would considerably raise the price per acre, but something to think about.
- -Upon selling any land the HNYLDC Board reiterated making sure there is language in the contract to ensure development of the parcel.

#### - New Business:

-2025 HNLYDC Budget is difficult to plan, as you never know when an opportunity can present itself. Doyle highlighted the following items below:

- Marketing was increased to include drone videos of the Crossroads site
- Real Estate Management budgeted \$22,750 for property maintenance; brush hog, fence repairs etc.
- Remainder of the budget included the reoccurring yearly expenses; audit, property insurance, taxes
